PREFACE TO THE FOURTH EDITION

This directory contains the names, internal extension numbers and direct line numbers of all BCCI Central Office staff in Abu Dhabi. Most of the divisions are located in Al Otaiba Tower on Sh. Hamdan Street, but Audit, Systems & Operations and Treasury Divisions are in Corniche Tower. The Advisor's Office and some International Division staff are in BCC (E)'s Sh. Mohammad Bin Zayed Building.

Many people have requested a divisional list in this directory and this has now been included. This list contains, alphabetically by name, the Executives, Joint Executives and Officers in each division.

Pager numbers are now included in both the main and divisional directory listings and the table of pager numbers has been deleted.

Page III explains how to transfer a call from one Nitsuko PBX to another. Please read this; it is a very simple procedure and may save a caller from having to call back just to speak to another Division.

Every care has been taken to ensure the accuracy of the entries, particularly the correct spelling of people's names. Please accept our apologies for any mistakes and omission.

Please use the slips provided on page v for additions and corrections. These should be sent to Systems & Operations Division in Corniche Tower to ensure inclusion in the next edition.

Staff with pagers will see on their pager's display the telephone number of the person who paged them. *If you are going to page someone from an extension of a switchboard, it is essential that you inform the switchboard operator so that he or she can pass the resulting call to you.*



TELEPHONES IN CENTRAL OFFICE

All Divisions have one (or more) multi-line PBX (private branch exchange) which can have up to eight exchange lines and 24 "stations" attached. The manufacturer's name for it is the Nitsuko 824.

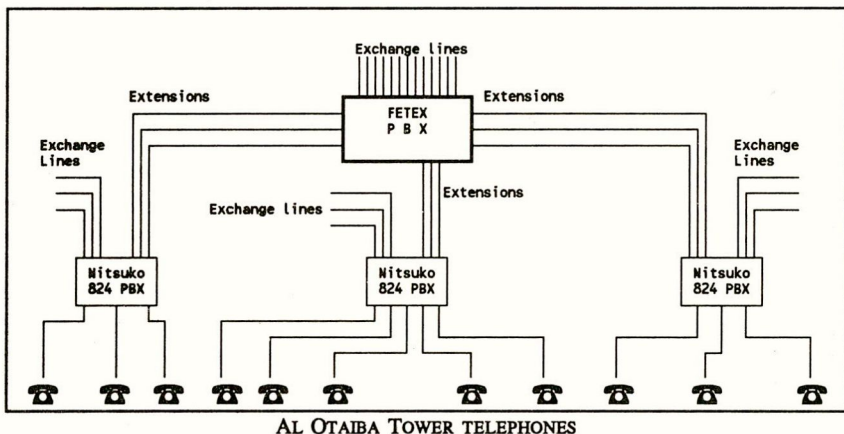
This system allows the user to select the incoming call from one of the eight line select buttons (usually the one that is flashing red). Similarly, the user can select an unused line in order to make a call.


It also provides an intercom facility between stations: press the ICM button to get the dial tone and dial the other person's station number.

If a Division has more than one Nitsuko PBX then intercom calls **cannot** be made between them. (See the diagram below).

Both Divisions in Corniche Tower and also the International Division staff in the BCC (E) building have one Nitsuko PBX each (the Advisor's office shares the International Division one). Other Division's staff should dial the number shown in the Direct Line column of this directory.

Al Otaiba Tower has a more complex system. The Fetex PBX on this main number (39 1600) is connected by three digit extension numbers to 15 Nitsuko PBXs as in the schematic below:



The telephone symbol  represents the instruments on the desks in Al Otaiba Tower. These are connected *through* the Nitsuko PBXs to the Fetex PBX and thence to the Abu Dhabi



exchange. Each Nitsuko also has its own lines to the Abu Dhabi exchange, although some of these are dedicated to individual officers and executives. Where this is the case, the number is shown in the Direct Line column in the directory pages.

Consequently, each telephone in Al Otaiba Tower has a *station number*, but it also has access to one or more three digit *extension numbers* on the Fetex PBX.

As the diagram shows, some of the eight *line select* buttons on your telephone will connect you to an *exchange* line and some will connect you to an *extension* of the Fetex PBX.

If your station number is **J14** and you want to call **J15** (ie, the same Nitsuko PBX) then you press the ICM button and dial 15.

If you want to call **K15** (a different Nitsuko PBX) then you have to select a line which is an *extension* and dial the three digit extension number allocated to the **K** PBX.

If you want to make an outside call then you can *either* select an exchange line and dial directly, *or* you can select an extension line and dial 9 (for a line) followed by the number.

Calls on 39 1600 are answered by the Fetex PBX operator and transferred to the relevant Nitsuko PBX. Station 10 will ring (although all stations' lights will flash) and the person who answers at station 10 can transfer the call using the ICM button.

HOW TO TRANSFER A CALL TO ANOTHER NITSUKO PBX

You take a call and the caller wants to speak to Mr X in another Division. Transferring this call is very easy. Look up Mr X's extension and tell your caller to hold on a moment. Then:

- press Flash - you will hear the internal dial tone;
- dial Mr X's extension and you should hear the ringing tone;
- when your call is answered, tell Mr X that there is a call coming through and then hang up. Your original incoming call has now been transferred.

Note: This will only work if the caller has come through on an extension of 39 1600. You cannot transfer a call that has come in on a direct line.
